Eligibility

Chinese citizens who have either acquired the right of abode or been granted unconditional stay in Hong Kong; or

Persons not of Chinese nationality who have been granted unconditional stay in Hong Kong but cannot obtain national passports or travel documents of any other countries or regions.

(i) Under the "Easy Travel Scheme", holders of Hong Kong identity cards bearing "***", "*" or "R" symbol or locally issued Hong Kong Note: permanent identity cards, who are aged 11 or over, can travel to and from the Mainland and Macau SAR through HKSAR without producing HKSAR Re-entry Permits or other travel documents at Hong Kong immigration control points. They are also not required to fill in arrival/departure cards.

(ii) If the child's facial appearance as compared to the photograph on the Re-entry Permit he/she is holding has changed, replacement of

Re-entry Permit may be applied for before the expiry of the current Re-entry Permit.

Application Channel



You must submit the application in person together with the child at any one of the offices listed at the back of the application form. Please produce the original copies of documents listed at (3) for verification.

Documentary Requirements and Fee

Documentary requirements

Re-entry Permit application form (ID73A);

- One recent photograph (The photograph should be taken in full face, without a hat. The background should be plain and of a light colour. The size must not be larger than 55 x 45 mm or smaller than 50 x 40 mm. The photograph will not be stuck onto the permit. It is used for reproduction of a digitised image. The quality of the image appearing on the permit will depend on the quality of the original photograph you
- The child's Hong Kong identity card (if appropriate);
- Documentary evidence of the child's legal residence in HKSAR;
- Consenting parent or legal guardian's Hong Kong identity card or valid travel documents;
- The child's birth certificate to prove the relationship between the consenting parent and the child, or a court order, if appropriate, to prove that the consenting legal guardian concerned has custodial rights in respect of the child; and

Additional requirements for children under 11 years of age

The latest school document bearing the child's photograph authenticated by the school (e.g. student's handbook or school record card, bearing the child's name, date of birth and photograph) or other proof of identity. If proof of identity is not available, a completed Form for Countersignature (ID641) together with a photostat copy of identity document of the person countersigning the form. (Form ID641 is available at the offices listed at the back of the application form or downloadable at the website www.immd ov.hk.)

Fee

For the fee and payment methods, please see (4)

If it is an application for replacement of Re-entry Permit, you have to produce the child's previous Re-entry Permit for cancellation upon submission of application.

If your child's previous Re-entry Permit is lost, damaged or is not available, you have to complete form ID645 obtainable at the offices listed at the back of the application form or downloadable at the website www.immd.gov.hk. The processing time may be longer.

Additional documents or information may be required if necessary.

An application with insufficient supporting documents will not be processed and will be returned to the applicant.

Payment Methods

Fee is collected upon issue of Re-entry Permit. The up-to-date fees are shown in the Fee Leaflet (ID912).

The Re-entry Permit good for a single journey is valid for 6 months. The multiple Re-entry Permit is valid for 5 years.

Take good care of your Re-entry Permit

Please keep your child's Re-entry Permit properly. Loss of Re-entry Permit takes time and money to replace. Do not easily entrust your child's travel document to a stranger. In the event of loss of the Re-entry Permit outside Hong Kong, you may contact our 24-hour hotline (852) 1868 for assistance. If you have planned to travel to and from the Mainland and Macau SAR, please apply early
